LEGIONELLA MANAGEMENT

Our interactive video-based training is aimed at all employers and staff to assist them in identifying the danger that Legionella poses. The Health and Safety at Work Act 1974 and HSE's code of practice L8 state that companies and building owners have a legal duty to manage Legionella. Learn to identify and assess sources of risk and implement effective control programmes.

FIRST AID

Emergency First Aid is the initial help given during an incident. While everyday first aid might involve something as simple as applying a plaster, this course prepares you for serious situations, highlighting common emergencies and appropriate actions. The Control of Asbestos Regulations 2012 require employers to provide training to anyone who might be exposed. ABRASIVE WHEELS

COSHH

The Control of Substances Hazardous to Health (COSHH) course is designed for anyone exposed to hazardous substances at work and their managers. Learn about substances legally classified as toxic, harmful, corrosive, or irritant under the CLP Regulation, and how to manage these risks effectively.

DISPLAY SCREEN EQUIPMENT

These courses are for users of display screen equipment (DSE) and those responsible for assessment. Covering monitors, laptops, tablets, and other displays, this training meets statutory requirements and teaches safe DSE setup to reduce work-related health conditions.
